Discussion on presentation and look at targeted maps/Habitat network

– Drainage issues

- Tree species diversity – climatic zones – elevation, soil type and size of woodland

Number of tree types to plant

- Freshwater Ecosystem group – link together re-drainage already working with group regards to lakes
- 5 layers – for Glastir – at or around £3m same as BWW – application window
- MVV - Glastir woodland creation nearly up to 6months – all native woodland – grant rates based on cost – higher cost on native woodland 95% - Scheme size on average quite small normally under 5 hectares – will discuss during next meeting some of the results from analysis, including appeals.

- Most things on appeal are BAP priority habitat

3 levels of data

Level 1- Hold resource – e.g. for woodland -woodland inventory/connectivity

Level 2 - Mapped areas – e.g. for Glastir

Level 3 – Produce a short list – key areas to if no action then there would be biodiversity loss – hard to pinpoint for woodland – have circulated possible sites – would still link map with boundaries – examples given but need final detail – key issues – Trevor Dines – to send list
